### Safeguarding Quick-Glance Flowchart

If you have a concern about the welfare of a child/young person or an adult at risk or the behaviour of an adult in relation to a child or an adult at risk **YOU MUST:**

- Record your concern in writing using the Safeguarding Incident form; and,
- Report your concern immediately to a Designated Safeguarding Officer,

**If the child or adult at risk is in imminent danger of harm you should refer directly to the police or social services without delay.**



On receiving the report of a concern,

The Designated Safeguarding Officer will:

1. Review the concern, along with any other relevant information and decide, often in liaison with others, what actions should be taken. Advice and support should be sought from any of the people listed below if you are unsure what action you should take;
2. Inform the Senior Designated Safeguarding Officer
3. Record in writing all actions taken, the reasons for these and by whom the actions were taken.
4. Refer to the relevant Social Services team or out of hours contact the Regional Emergency Social Work Service when appropriate. It is important to gain consent for any referrals to Adult Services if the person has capacity.

**If the child or adult at risk is in imminent danger of harm you should refer to the police or Social Services without delay.**

## IMPORTANT CHANGE TO CHILD PROTECTION POLICY

There has been an update to the Northern Ireland GUIDELINES. A new category of abuse has been added.

Ill-treatment of another or abusive behaviour directed at another means that a child could be harmed by virtue of witnessing the ill-treatment or domestic abuse of another person. However, it is not necessary for the child to have witnessed such treatment or behaviour or, indeed, to have been present when it happened. Abusive Behaviour is behaviour that falls within section 2 of the Domestic Abuse and Civil Proceedings Act (NI) 2021.
